ENROLMENT OF STUDENTS WITH SPECIAL NEEDS

The Term, 'Children with Special Needs' refer to **all** children who require additional professional, specialist assistance / therapy and /or one on one adult guidance and supervision in their development.

Terms and conditions as stated in BRMCK Rules and Regulations, Clause 45 -Children with Special Needs and BRMCK's website – Children With Special Needs (www.brmck.edu.sg) apply :

Barker Road Methodist Church Kindergarten is primarily a mainstream kindergarten and is not equipped to provide the required care for children with special needs.

Given our limited resources and lack of professional expertise in the field of special needs, Barker Road Methodist Church Kindergarten aka BRMCK can only **endeavor to assist** Special Needs Professionals to nurture **one** high functioning child with special needs within each BRMCK class.

All special needs students **must** be accompanied by a professional special needs shadow teacher or a specially trained adult care giver at all times.(Please note that permission for the latter will be reviewed and granted on a case by case basis.) This is regardless of the category of special needs and level of function.

Parents/Guardians of the special needs child **must pledge unreserved and full indemnity** for Barker Road Methodist Church, Barker Road Methodist Church Kindergarten, its board of management, the BRMCK Principal and Staff as well as BRMCK's service providers **from all manner of liability and blame** in the event of any negative, untoward occurrence resulting in any form of injury, death, adverse emotional and / or physical health and /or any other negative development (mentioned and / or unmentioned) in/of their child.

In the event that your child is a child with special needs but you have not informed BRMCK upon registration, BRMCK reserves the right not to admit or to de-register your child. BRMCK further reserves the right not to admit or to de-register your child at any time if BRMCK is of the view that it is unable to accommodate the special needs of your child or if your child poses an unacceptable risk to other students, to BRMCK staff or property or equipment,
